TELLURIDE REGIONAL AIRPORT AUTHORITY BOARD MEETING

**July 21, 2011
12:00 pm**

CALL TO ORDER

Chairman John Micetic called the meeting of the Telluride Regional Airport Authority to order.

Roll Call

Present Members: Chairman John Micetic, Vice-Chairman Ed Roufa. Board members Ann Brady, Stu Fraser, Joan May, Gary Bash and John Steel.

Alternate Members Present: Lynne Beck.

1. APPROVAL OF MINUTES MOTION

Board member Ann Brady moved to approve the minutes of June 16, 2011.
Vice-Chairman Ed Roufa seconded the motion.
Approved 7-0.

2. APPROVAL OF ACCOUNTS RECEIVABLE AND PAYABLES

Rich updated the Capital Budget for 2011 and explained the change regarding the potential fees for the law suits. Rich explained he will now pay for the attorney's fees out of the Capital account instead of the Operating Account.

MOTION

Board Member Stu Fraser moved to approve the Accounts Receivables and Payables and the 2011 Capital Budget.
Board member Ann Brady seconded the motion.
Approved 7-0

3. CHAIRMAN'S COMMENTS

Chairman John Micetic mentioned the Special meeting regarding personnel. John said in that meeting a suggestion from Jon Dwight was to have the Telluride Airport's fuel prices be higher than Montrose. John wants to give Rich all the support and tools he needs to market the Airport. Board agreed to give Rich the flexibility to set his prices and market the Airport as he sees fit. A good suggestion from visitor Scott Stewart was to have quarterly meetings with the tenants to help improve customer service.

Discussion was held regarding the contract for improving the terminal. There was a miscommunication in regards to the sub-contractors on that job.

4. NOISE ABATEMENT REPORT

Rich received a few calls regarding a plane landing on Runway 9. According to the crew, the winds were at 9 knots. Complaints were also received from the Mesa.

Rich presented a new concept of a “Whispertrack” regarding Noise Abatement Procedures for airports worldwide. It is a program that gets our Noise Abatement Procedures out to all pilots efficiently. It cost \$245 a month.

MOTION

Vice-Chairman Ed Roufa moved to accept the Whispertrack and review it in six months. Board Member John Steel seconded the motion.

5. AIRPORT’S MANAGER COMMENTS

Updates:

- A. FAA is in the process of reviewing the waiver for the 10,000 enplanements for 2010.
- B. Enplanements for entitlement dollars do not include non-revenue passengers. The enplanement reports will be adjusted this year.
- C. C&D Categories – The FAA lead the Airport to believe they were working on the approach plates for C&D. They are at this time not responding to Rich’s correspondence or phone calls. Rich said if they don’t respond within the next 30 days, then the Board could write letters to our Congressmen. Rich will put something together for Joan May and Stu Fraser. Board decided to act immediately instead of waiting for the 30 days.

Water Tank: Meeting was held with several water specialists to review current plans and what should be done with the tank. The recommendation was to purchase the water augmentation off-site, to alleviate that issue. John Steel attended the meeting and fully endorsed their recommendation.

Ed Roufa left the meeting at this time

Board Member Ann Brady moved that the Board allow Rich to proceed with his plans to secure the water augmentation and to obtain a new well.

TRAA Board gave permission for Rich to purchase a crew car and convert it to an electric vehicle.

Grant Updates

The following is an update regarding our FAA and State grants:

- AIP-22: This project has been completed. The final claims by contractor have been settled. The FAA has notified me that funds are now available to close this grant. This should be completed within the next few weeks.

- AIP-25: Phase II, Runway/Safety Area Improvements. This project has been completed. Grant still open pending final close-out documents and settlement of claims.

- AIP-26: Phase III, Runway/Safety Area Improvements. This project is complete except for some additional work required on the water tank.

- CDOT Grant: Apron project is now completed. There are just a few check-list items remaining and the installation of the lights, which were delayed due to manufacturer's production delays.

FAA Part 139 Inspection

On July 25th and 26th the FAA completed its annual Part 139 airport inspection. The inspector found all of our paperwork in order and the airfield and equipment meeting all the standards. We had two minor items relating to a pavement lip and switching a sign position that we were able to correct immediately while the inspector was here, so there is no follow-up measures required.

The inspector also was pleased with our new training videos that we have produced in the last few months.

Budget Rent-A-Car

After consultation with owner Michael Skelton from Budget Rent-A-Car he has agreed to provide a marked van to pick-up his customers at the Airport and transport them to his off-site location. This should insure adherence to the Airport's Rules & Regulations.
